Pre-packaged Aquatic Food Products

■ Aquatic Products

Including fish (e.g. sardines, salmons), shellfish (e.g. scallops), crustaceans (e.g. shrimps, crabs) and echinoderms (e.g. sea cucumbers), etc.

■ Pre-packaged Aquatic Food Products

Aquatic Food Products, such as canned fish, pre-packaged shredded squid, etc., which are processed by cooking, drying, salting or chopping, etc., and sealed in food grade packaging or containers.



Targeted Food Surveillance

- **Objective:** The Centre proactively identifies potential risks of the targeted food items and assesses the safety of food items commonly consumed in Macao in order to safeguard food safety.



Targeted Food Surveillance

- The Centre conducts relevant analysis based on the types of food. Priority will be given to the popular food items.

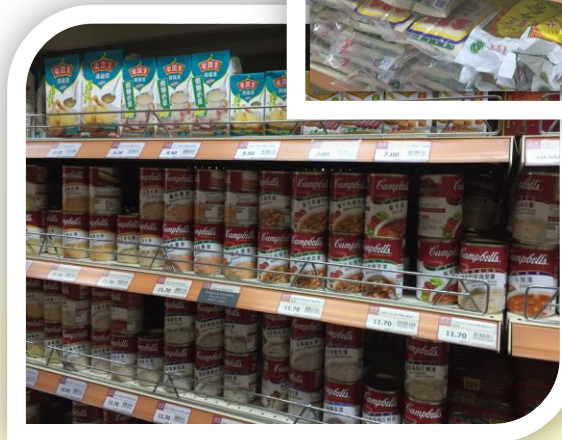

Surveillance on Pre-packaged Aquatic Food Products

- Pre-packaged aquatic food products such as canned fish, shredded squid are commonly consumed in Macao. Heavy metals prone to accumulate in fish, shellfish and other aquatic food products. In addition, general processing cannot eliminate heavy metals in aquatic food products. If contaminated aquatic food products are consumed, heavy metals may enter the body through the food chain.
- Long-term intake of excessive heavy metal from contaminated food may cause damage to the kidney, liver, central nervous system and other organs, particularly to young children, pregnant or breastfeeding women .

Surveillance on Pre-packaged Aquatic Food Products (cont.)

- Food additives such as sweeteners and preservatives may be added to enhance the flavor (e.g. sweetness) and extend the shelf life of pre-packaged aquatic food products.
- Long-term intake of excessive food additives may cause health damage.
- In order to assess the safety of pre-packaged aquatic food products, the Food Safety Centre of IACM carried out this food surveillance.

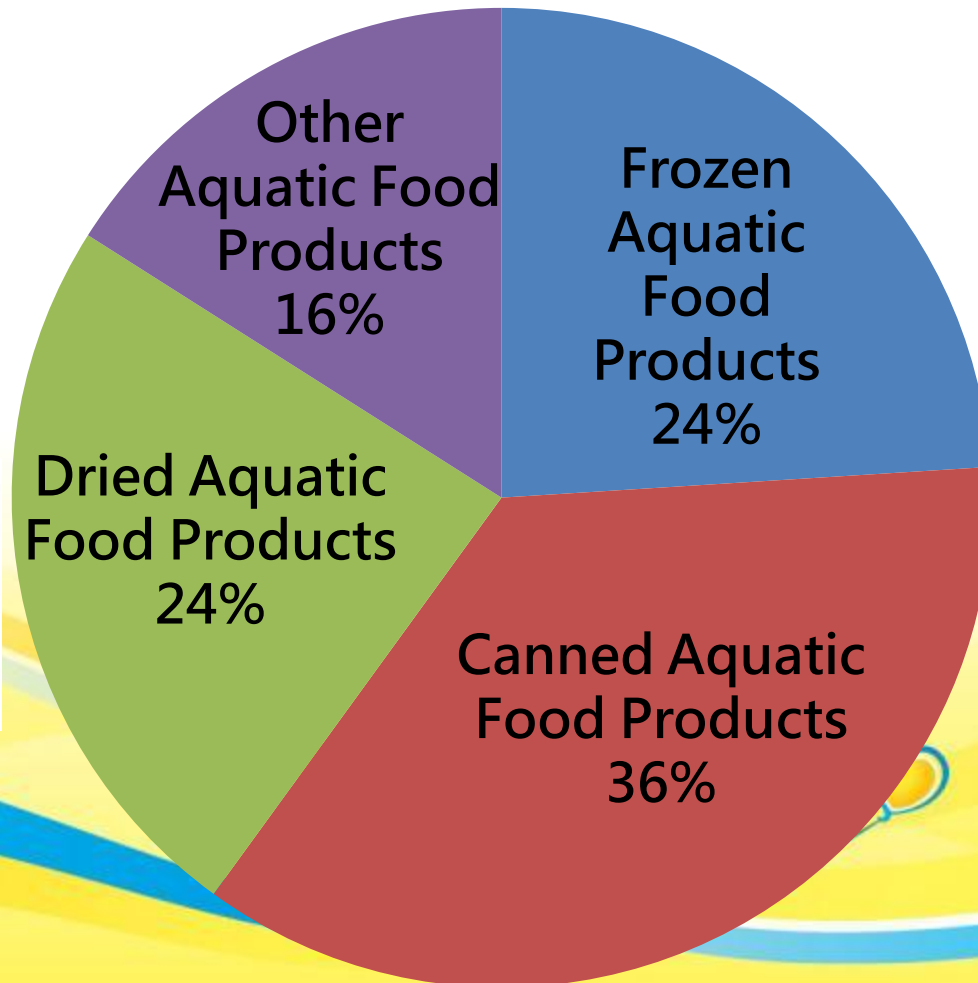

Types of Samples

■ Collected a total of 50 samples of pre-packaged aquatic food products , which include:



Test Parameters

■ Heavy metals

Lead, Cadmium, Arsenic, Mercury and Tin, in total of 5 tests

■ Food Additives

Sweeteners: Acesulfame potassium, Aspartame, Saccharin, Stevioside and Neotame , in total of 5 tests.

Preservative: Sorbic acid , in total of 1 test.

Test Results

- All the samples were satisfactory. The overall **satisfactory rate was 100%** ;
- Although the results were satisfactory, IACM reminded the public to maintain a balanced diet, and consume moderate amount of pre-packaged aquatic food products ;
- In addition, phenylketonuria patients or people who are sensitive to food additives, such as sweeteners, should read the food label in detail when purchasing pre-packaged aquatic food products. If necessary, consult your doctor before purchasing and consumption .

Advice To The Public

When purchasing pre-packaged aquatic food products, you should:

- Purchase from approved and reliable sources ;
- When purchasing pre-packaged food, check the package if it is intact and pay attention to the expiry date, and store them according to the label instructions after purchase ;
- Consume as soon as possible after opening ;
- When purchasing food online, it is not easy to verify whether appropriate measures have been put in place during storage, transport, etc. to ensure food safety. The public should pay special attention to the nature and potential risks associated with the food items that they bought online .
- Do not purchase or eat any food if there is any doubt about its safety or quality.

Advice To The Trade

- The trade should purchase food products from reputable suppliers, meet the hygiene and safety requirements in various food processes, such as transportation and storage, store and display the food properly ;
- The trade should **keep all the purchase and sales records** for product tracing by the competent government authorities whenever necessary ;
- Do not sell any food if there is any doubt about its safety or quality, e.g. the package is damaged, canned food appears to be bulged .



保存食品紀錄指引

目的：

根據《食品安全法》，食品生產經營者有義務在指定期間內保存進出貨紀錄或相關單據。本指引旨在使食品生產經營者了解保存食品紀錄的要件及如何妥善進行相關的保存工作，以便一旦發生食品事故時能讓政府有關部門進行及時有效的食品溯源及跟進工作，共同攜手保障本澳的食品安全。

適用範圍：

- 適用於所有擬供人食用的食品。根據《食品安全法》，「食品」指任何供人食用的經處理或未經處理的物質，包括飲料及香口膠類產品，以及在生產、配製及處理食品過程中所使用的所有成分。
- 本指引旨在為食品生產經營者提供原則性的保留食品紀錄建議，但受現行其他指引規範者，則可沿用既有規定。

保存紀錄的內容：

為有效追查食品的來源和流向，保存紀錄的內容應清晰並涵蓋以下資料：

1. 食品的日期(獲取食品的日期；以批發方式供應食品的日期)；
2. 食品的來源資料(公司或個人的名稱、地址及電話)；
3. 食品的数量；
4. 食品的描述(應為特徵性描述，讓人可清楚辨識，如食品名稱、批號及產地來源等)。
