Targeted Food Surveillance

Objective: The Centre proactively identifies potential risks of the targeted food items and monitors the safety of food items that are commonly consumed in Macao in order to safeguard food safety.

Targeted Food Surveillance

The Centre conducts relevant analysis based on specific food categories.
Priority will be given to the popular food items.



Surveillance on Pre-packaged Complementary Foods for Infants and Young Children

- Scope: Complementary foods for infants and young children circulating in Macao.
- Infants and Young Children: Age 0-36 months, considered as high risk group.
- Complementary foods for infants and young children which help them to adapt solid foods while getting enough nutrition. These include purees for baby, infant biscuits and infant cereal, etc.
- To ensure complementary foods for infants and young children in Macao market comply with the requirements of food hygiene and safety standards, Food Safety Center of lacm carried out a targeted food surveillances.

Market Surveillance


Popularity

Complementary foods for infants and young children in the market, including well known brands in the market. Country of Origin China, Taiwan, Japan, US, Australia, Switzerland and France, etc.

Location Local Supermarkets, baby stores and department stores

Types of Samples

Collected a total of 30 samples of pre-packaged complementary foods for infants and young children, which include:



Types of Test

Microbiological Analysis

Salmonella, Staphylococcus aureus and Bacillus cereus.

Radiation level analysis

Iodine-131, Cesium-134 and Cesium-137.



Test Results

All tested samples were satisfactory. The overall satisfactory rate was 100%.

Despite the fact that all the samples tested were satisfactory, individual differences like infant growth rate, physical condition and food intake should be taken into accounts, if you have any doubt, consult your doctor before introducing complementary foods to your infant or child.

Advice for consumers

When purchasing pre-packaged complementary foods for infants and young children, you should:

- Purchase from approved and reliable sources;
- Check the packaging if it is intact and pay attention to the expiry date;
- Store the products properly according to the label instructions, purchase food in the amount as needed, and consume as soon as possible after opening;
- It is difficult to verify whether the online food trading meet the food safety standard in various food processes, such as transportation and storage, the public should pay special attention to the food properties and potential risks when purchasing food online;

Consult your doctor before introducing complementary foods to your infant or child;

Do not purchase or consume any food if there is any doubt about its safety or quality.

Advice for trade

- The trade should purchase food products from reputable suppliers, meet the hygiene and safety requirements in various food processes such as transportation and storage, store and display the food properly;
 - The trade should keep all the purchase and sales records for product tracing by the competent government authorities whenever necessary.

Do not purchase or sale any food if there is any doubt about its safety or quality.



保存食品紀錄指引

目的:

根據(食品安全法》。食品生產經營者有義務在指定期間內保存進出貨紀錄或 相關單據 • 本指引冒在使食品生產經營者了解保存食品紀錄的要件及如何妥善 進行相關的保存工作,以便一旦發生食品事故時能讓政府權限部門進行及時有 效的食品溯源及跟進工作,共同攜手保障本演的食品安全。

適用範圍:

- 適用於所有擬供人食用的食品。根據《食品安全法》,「食品」指任何供人食用的經處理或未經處理的物質,包括飲料及香口膠類產品,以及在生產,配製及處理食品過程中所使用的所有成分。
- 本指引旨在為食品生產經營者提供原則性的保留食品紀錄建議,但受現行 其他指引規範者,則可沿用既有的規定。

保存紀錄的內容:

- 為有效迫查食品的來源和流向,保存紀錄的內容應清晰並涵蓋以下資料:
- 食品的日期(獲取食品的日期;以批發方式供應食品的日期);
- 食品的來源資料(公司或個人的名稱 · 地址及電話);
- 食品的數量;
- 食品的描述(應為特徵性描述)讓人可清楚辨識,如食品名稱,批號及產 地來源等)
