<p>預警發出之原因 Motivo da Emissão de Alerta Reasons for Issuing Alert</p>	<p>根據香港食物安全中心發出的新聞公報，指該中心透過恆常食物監測計劃，從一網上商店抽取上述產品樣本作檢測，結果顯示，樣本含百萬分之零點一七九的蘇丹紅一號及百萬分之零點零四三的蘇丹紅四號，現正進行回收。 The Hong Kong Centre for Food Safety (CFS) announced that the CFS has collected the above-mentioned samples from an online shop for testing under its routine Food Surveillance Programme. The test result showed that the sample contained Sudan I at a level of 0.179 parts per million and Sudan IV at a level of 0.043 parts per million, and the affected batch of the product is now being recalled.</p>
